# Global transactions

## Corporate and M&A

# Antitrust and competition

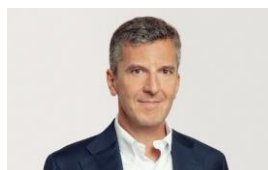

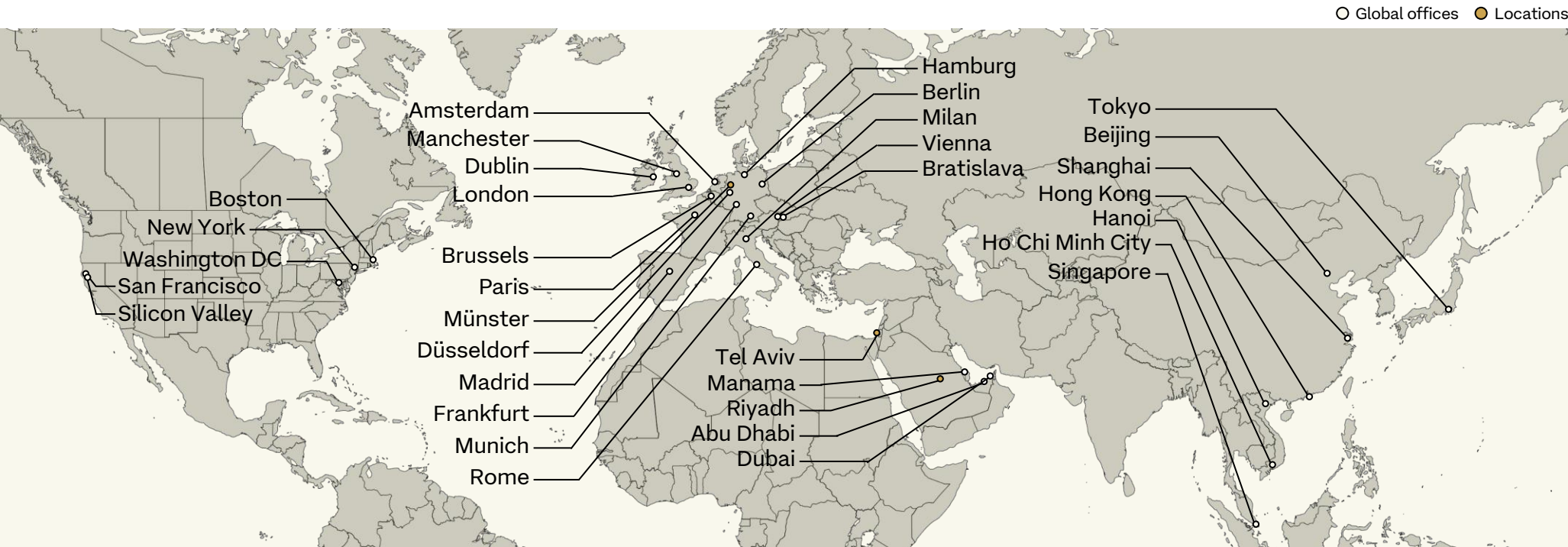
